➡ Upon faxing or submitting this Rental Agreement to MobileLBS Inc. I will be charged \$150.00 Weekly or \$300.00 Monthly plus GST (Ontario residence pays an additional 8.0% tax) for my Microtrack rental fee, and a one-time 100% Refundable deposit of \$600.00, for a total of \$900.00 plus shipping and applicable taxes. \_\_\_\_\_ (initial)

➡ My \$600.00 Deposit is to cover possible damage/loss of my Microtrack and its parts and is 100% Refundable upon my return of my Microtrack in good working order & condition. If my Microtrack unit is deemed damaged, inoperable or unusable upon return by MobileLBS Inc. any labor and/or parts charges to repair/replace the unit will be debited from my deposit and will not be refunded \_\_\_\_\_ (initial)

➡ I understand that I will be charged the lesser of \$150.00 per week or \$300.00 per month plus GST (Ontario residence pays an additional 8.0% tax) to my credit card, as per my contract term every 30 days I have the Microtrack. \_\_\_\_\_ (initial)

➡ Minimum Rental period is one week and rental fee is **NOT PRORATED** and **NON REFUNDABLE**. No partial refunds will be given if I return the Microtrack early. \_\_\_\_\_ (initial)

➡ I am responsible for all shipping charges to return the Microtrack. To MobileLBS \_\_\_\_\_ (initial)

➡ I understand that if the Microtrack is not returned, regardless of the reason, my deposit will not be refunded and I will be responsible for replacement of additional hardware, software and replacement charges. \_\_\_\_\_ (initial)

➡ My rental period begins the first business day after I have delivery receipt. In the event of shipping errors, MobileLBS Inc. will amend my rental period to reflect the corrected date of delivery. If I do not accept delivery, I will be charged one month's rental fee of \$300.00 plus GST (Ontario residence pays an additional 8.0% tax) to cover processing, shipping, and inventory expenses. \_\_\_\_\_ (initial)
